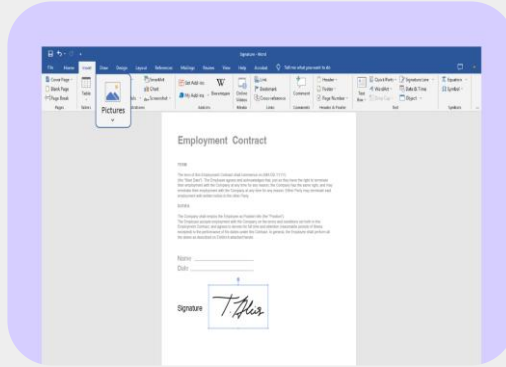


Physical signature
